U.S. Supreme Court Decision Puts an End to "Chevron Deference"

In Bulletin 53-2024, we informed members about the U.S. Supreme Court ruling in Loper Bright Enterprises v. Raimondo, ending the 40-year-old precedent of "Chevron deference." Federal judges will now have the power to exercise independent judgment in interpreting statutes and reviewing an agency's interpretation of the law.
