OSHA COVID Resources & Information on Respiratory Protection Certifications

In an email blast on April 7, we updated members on OSHA's available resources and provided temporary guidance on the enforcement of OSHA's Respiratory Protection Standard.

Governor Murphy Halts Non-Essential Construction Work

In an email alert on April 7, ACCNJ gave members an advance update that Governor Murphy would shut down non-essential construction on Wednesday, April 8, 2020. As anticipated, on April 8, Governor Murphy signed Executive Order #122 to halt "non-essential" construction work.

FFCRA Requirements for Collectively Bargained Employees

In email alerts on April 8 and April 27, we distributed to members NJ Earned

Sick Leave and FFCRA guidance, focusing particularly on its application to employees covered under Collective Bargaining Agreements.

Product Supplies: Masks, Face Shields & Hand Sanitizer

In an April 9 email blast, we directed members to vendors with stock of masks, face shields and hand sanitizer available for purchase.

OSHA Further Clarifies Employer Requirement to Record & Report COVID19 Cases

On April 11, ACCNJ distributed an email alert informing members the Occupational Safety and Health Administration (OSHA) issued temporary guidance for recording cases of COVID-19 that provides relief to the construction industry. To view OSHA's full enforcement memo, <u>click here</u>.

AGC of America Action Alert

On April 16, ACCNJ, in conjunction with AGC of America, asked members to "Take Action," and tell the Trump Administration and Congress to include immediate funding for state departments of transportation (DOTs) in future COVID-19 relief legislation.

PA Governor's EO Amendment Addresses Resumption of "Limited Construction Activity"

On April 21, we notified members Pennsylvania's Governor Wolf issued an amendment to the original Executive Order issued March 19th to allow the resumption of "limited construction activity," starting Friday, May 8th. On April 24, we updated members of a revised construction start date, moving the May 8th date originally outlined in his plan to May 1st.

Benefit Extension - Non-Working Wages/Hours

In an email alert on April 22, we informed members of several trades that have agreed to temporarily extend the due date for fringe benefits by 30 days. Additionally, several trades whose collective bargaining agreements require fringe benefits on all hours paid, have agreed employers may make wage payments to employees FOR TIME NOT WORKED without paying fringe benefit contributions, except those required by law.

On April 24, we distributed the Emergency Contribution Relief Matrix, which provides you with a summary of those trades and the applicable temporary changes to their respective collection policies.

FEMA Bulletin and OSHA Guidance for the Construction Industry

In an April 23 email blast, we distributed to members guidance provided by OSHA and FEMA to incorporate into preparedness plans and protocol for jobsite safety.

Additional \$310 Billion to Support PPP Loans

On April 24, we notified members Congress passed legislation to further combat COVID-19's impacts to our country by providing \$310 billion in new

funds for the "Paycheck Protection Program," \$60 billion for Small Business Administration disaster assistance loans and grants, \$75 billion in grants to hospitals and \$25 billion to bolster coronavirus testing.

Governor Murphy's Road Back to Economic Health

In an email alert on April 27, we informed members Governor Murphy announced his Administration's plan - "The Road Back: Restoring Economic Health Through Public Health." ACCNJ Weekly Update on COVID-19

New Jersey's Workers' Compensation Laws

In an April 28 email alert, we informed members NJ's Department of Banking and Insurance (DOBI) gave explicit direction to its division, NJ Compensation Rating and Inspection Bureau (CRIB), to exclude all COVID-19 claims from the experience modification rating (EMR) calculation.

NJTA Proposed Toll Schedule and Capital Plan

In early April, ACCNJ submitted formal comments to the New Jersey Turnpike Authority Commissioners in support of the proposed toll schedule and subsequently supported capital program. The toll or fare increases are necessary to improve service for the taxpayers and to enable longer-term capital planning for the State.

NJ P3 Regulations Finalized
