Members are reminded to post the OSHA Form 300A by February 1, 2018, in a common area where notices to employees are usually posted. The form summarizes job-related injuries and illnesses logged during 2017, and must remain posted through April 30, 2018. For more information, visit www.osha.gov.

OSHA Penalties Rise for 2018

OSHA penalties are higher beginning this month in accordance with the inflation adjustment formula written into the 2016 rule. Effective January 2, penalty for a serious violation is \$12,934; failure to abate is \$12,934 per day beyond the abatement date; and willful or repeated violations will be penalized \$129,336 per violation.
