COVID-19 Updates

OSHA Issues ETS for Healthcare and General Guidance for All Industries

In an ACCNJ Alert distributed on June 11, we informed members OSHA has issued an [Emergency Temporary Standard \(ETS\)](#), which will only apply in healthcare settings and not in other industries. SBA to Withdraw Loan Necessity Questionnaire for PPP Loans

In an ACCNJ Alert distributed on June 24, we notified members the U.S. Small Business Administration (SBA) intends to withdraw the "Loan Necessity Questionnaire," which slowed the forgiveness process for PPP loans over \$2 million. Additionally, we provided the information that forgiveness determinations have finally begun to trickle in for loans over \$2 million.

Government Affairs

End to New Jersey's Public Health Emergency

In Bulletin 60-2021, we informed members Governor Murphy signed A-5820 / S-3866, which enables the end of the State's "health emergency" that has been in place since March 9, 2020. Under the legislation, the majority of executive orders issued in response to the pandemic will expire on July 4, 2021. In addition, the bill contains a provision that any masking and social distancing requirements imposed by the State shall not be more restrictive than those recommended by the CDC.
