
In Case You Missed It

NJ Vaccine Mandate — EO 271

In an ACCNJ Alert distributed on October 21, we informed members Governor Murphy issued <u>Executive Order 271</u> ("EO 271"), which will impose a COVID-19 vaccine mandate on contractors who work "on or in connection with" certain State government contracts. Members who perform public work are encouraged to carefully review EO 271 in its entirety.

Bargaining Rights Authorization Forms

In Bulletin 86-2021, we informed Active members the collective bargaining agreements between the Associated Construction Contractors of New Jersey and the following trades expire on April 30, 2022:

If you currently assign your bargaining rights to ACCNJ for any of these trades, we strongly encourage you to continue to do so by completing the Bargaining Rights Authorization forms.

Government Affairs

Federal Infrastructure Bill Vote Delayed;

Federal Highway Spending Program Subsequently Suspended 30 Days

In Bulletin 87-2021, we informed members a US House of Representatives final vote on the \$1.2 trillion federal infrastructure spending bill has been delayed. Conversely, President Biden signed a 30-day extension of the federal highway spending program.

In Bulletin 92-2021, we updated members that the final vote was delayed *again*. The House also passed another short-term extension of highway and transit construction programs that were set to expire Sunday, October 31st to avert any halts on federally funded projects.

Tuition Reimbursement Program

NJ Alliance for Action Forecast

On October 28, 2021, the New Jersey Alliance for Action released a construction forecast projecting \$31 billion in capital investments across the state in 2022 and 2023.

The largest construction projections were presented by leaders of the utility, transportation, higher education, office, healthcare, industrial, school and environmental industries.
